Amendment to **HB 679**

Change Subdivision 10, subparagraph (b) to read as follows:

“(b) A person who is elected as a delegate to the national convention at the primary or who is selected as a delegate or alternate to the national convention by the state convention, and who does not resign from the position, is pledged by law to support at the national convention the candidate on whose slate he was elected or by whose caucus he was chosen, until the candidate is nominated at the convention or until ~~[the candidate releases the delegate or alternate from the pledge.]~~ the delegate or alternate is released from the pledge as follows:

(4) Fourth and Subsequent Nominating Convention Ballots: delegates and alternates are by law released from any pledge.

WHEREAS, On February 27, 1795, one of the most outstanding figures in Texas history, Don Jose Antonio Navarro, was born in Villa de San Fernando, Presidio de San Antonio de Bexar, in the Province of Texas in Spanish America; and

WHEREAS, When local rebellion broke out in 1811, he took part and, two years later, at age 18, went into exile following the defeat of the local insurgents at the Battle of Medina; and

WHEREAS, He received a royal pardon from the King of Spain after spending three years in Louisiana and promptly returned to San Antonio de Bexar to help

rebuild the city; and

WHEREAS, In 1821, at age 26, Don Jose Antonio Navarro became the Alcalde of the city of San Antonio, the last one under Spanish rule; and

WHEREAS, After a period of service as land commissioner for the Bexar District and the DeWitt Colony, and following the Treaty of Cordova and Mexican Independence from Spain, he was elected in 1829 to represent the Department of Bexar in the Chamber of Deputies at Saltillo, capital of the Mexican state of Coahuila and Texas; and

WHEREAS, Don Jose Antonio Navarro was again chosen by the people of Bexar to represent them at the Convention of 1836 at Washington-on-the-Brazos and there became one of two native Texans who took part in the signing of the Texas Declaration of Independence and the only native Texan who served on the special committee which drafted the Constitution of the Republic; and

WHEREAS, In 1838-39, as the congressman from Bexar County to the Third Congress of the Republic, he cosponsored the Public School Act, which provided that three leagues of land be set aside in each county for primary schools or academies and fifty leagues for establishment of two colleges or universities; and

WHEREAS, In 1841, while acting as a commissioner on the ill-fated Santa Fe Expedition, he was captured by Santa Anna's forces and sentenced to death, but when the sentence was later commuted to life imprisonment, he was eventually able to arrange an escape from Mexico; and

WHEREAS, In the transition of the Republic of Texas to statehood, Don Jose Antonio Navarro participated as a member of the State Constitutional Committee in 1845, and as an authority on Spanish law he gave to Texas four fundamental laws of today, the laws of community property, the law of separate property rights for married women, the laws of descent and distribution, and the homestead law; and

WHEREAS, A delegate to the convention at Austin that joined the Republic of Texas to the United States in 1846, he also became the first senator from Bexar County to the Texas legislature when statehood was achieved; and

WHEREAS, He died in January of 1871, one of the most highly honored and revered citizens of Texas; and

WHEREAS, As an expression of appreciation for his patriotic service, the State of Texas named Navarro County in honor of Don Jose Antonio Navarro and named its county seat, Corsicana, to commemorate his father's birthplace, the Island of Corsica; and

WHEREAS, It is appropriate that Texans be reminded of the contributions of this devoted patriot on the occasion of the 180th anniversary of his birth; now, therefore, be it

RESOLVED by the House of Representatives of the 64th Legislature of the State of Texas, the Senate concurring, That the Texas legislature pay tribute to Don Jose Antonio Navarro, one of the foremost statesmen and patriots in Texas history; and, be it further

RESOLVED, That the week of February 23 to March 1, 1975, be designated as Don Jose Antonio Navarro Week in Texas; and, be it further

RESOLVED, That an official copy of this resolution be prepared for Navarro House, his old home in San Antonio, and for his direct descendants, Adela M. Navarro and Jose Antonio Navarro V, both of San Antonio, as a tribute by the Texas legislature in memory of an illustrious figure in Texas history, Don Jose Antonio Navarro.

WHEREAS, The State of Texas has lost a distinguished citizen and members of the Texas legislature a good friend and former colleague with the death of former State Representative Joe Shannon, Sr., on January 18, 1975, at the age of 59; he was the last representative to serve from the Tarrant flotorial district and had been a prominent attorney in Fort Worth for many years; and

WHEREAS, A long-time resident of Fort Worth, Mr. Shannon was the son of Dr. J. B. Shannon, a physician in that city for 38 years, and attended North Texas Law School; and

WHEREAS, Mr. Shannon became interested in state politics at the early age of 18, when he actively campaigned through North Texas for the gubernatorial candidate, Tom Hunter. Two years later, he became a candidate for state representative; he finished first out of ten candidates, but lost in the run-off election; and

WHEREAS, In 1942, he became a member of the United States Army Air Corps, serving as a tailgunner on B17s during 32 missions over Europe, and earning the Air Medal with three Oak Leaf Clusters and the Distinguished Flying Cross. Having participated in missions over Berlin and Normandy during D-Day, this courageous military man was once involved in a mission that dropped supplies to the underground in Warsaw, Poland, and went on to land in Russia before returning to England; and

WHEREAS, Upon his return to Fort Worth in 1946, he became an assistant district attorney under District Attorney Al Clyde. In 1948, Mr. Shannon returned to politics and served as state representative from Tarrant and Denton Counties from 1948 to 1952; and

WHEREAS, His well-known and respected law practice with Otis Rogers and Joe Spurlock, Sr., begun in 1938, remained prominent in Fort Worth for over three decades. Mr. Shannon was a member of Veterans of Foreign Wars Post 703 and the American Legion Business and Professional Men's Post; and

WHEREAS, A faithful and devoted family man, Mr. Shannon was also a member of the College Avenue Baptist Church, the Southside Masonic Lodge, and the Moslah Shrine Temple; and

WHEREAS, The people of Fort Worth and the entire state and, especially, his former colleagues in the Texas legislature, will miss this distinguished and devoted citizen, and his service to the State of Texas will be long remembered; now, therefore, be it

RESOLVED by the House of Representatives of the State of Texas, the Senate concurring, That the 64th Legislature pay tribute to the outstanding life of service of the Honorable Joe Shannon, Sr., veteran of World War II, former attorney and state representative, and prominent citizen of Fort Worth, and extend sympathy on their great loss to the members of his family: to his wife, Mrs. Juanita Shannon; his son, Joe Shannon, Jr., of Fort Worth; and his daughter, Miss Nancy Shannon of Fort Worth; and, be it further

RESOLVED, That official copies of this resolution be prepared for the members of his family, and that when the Texas legislature adjourns this day it do so in memory of Joe Shannon, Sr.
