WHEREAS, A true patriot, Dr. Pittman honorably served his country in the United States Army during the Korean War; and

WHEREAS, A man of great ability and unquestioned integrity, Dr. Pittman had been named Optometrist of the Year in 1984 by the Texas Optometric Association and in 1987 by the American Optometric Association; in 1989 he was the recipient of the Texas Optometric Association's highest award, the Distinguished Service Award; and

WHEREAS, Dr. Pittman generously donated his time and talents to numerous professional organizations; he was chairman of the American Optometric Association's State Legislative Affairs Committee and a member of the Executive Committee of the American Optometric Association's Member Services Center; this renowned and respected medical man further contributed to his profession as co-chairman of the Legal and Legislative Committee of the Texas Optometric Association and vice-president and state programs chairman of the Texas Society to Prevent Blindness; in addition, he was twice selected as a governor's appointee to the Texas Optometry Board of Examiners; and

WHEREAS, An affectionate and loyal friend to his colleagues, Dr. Pittman was always there to provide support and encouragement for them; a man who was comfortable with others in any circumstances, Dr. Pittman was as relaxed sitting in Speaker Gib Lewis's office discussing legislation as he was telling jokes at deer camp; his presence will be greatly missed; and

WHEREAS, Well known as an activist in his community, Dr. Pittman faithfully addressed the needs of his fellow citizens as Mayor of Mexia, Mexia City Commissioner, president of the Mexia Rotary Club, and president of the Mexia Chamber of Commerce; and

WHEREAS, A sincere and dedicated Christian layman, Dr. Pittman was a Sunday school teacher and deacon at the First Baptist Church; and

WHEREAS, His memory will remain forever in the hearts and minds of all who knew him; now, therefore, be it
