### AFTER RECESS

The Senate met at 8:00 a.m. and was called to order by Senator Harris.

(6) In Section 30.30(a) of the bill, strike proposed Section 452.2515(b-1), Transportation Code (introduced version, page 646, lines 4-7).

(7) In Section 30.33(a) of the bill, proposed Section 453.2515(b), Transportation Code (introduced version, page 650, line 22), strike "After August 31, 1996, at" and substitute "~~At~~ [~~After August 31, 1996, at~~]".

(8) In Section 30.150(a) of the bill, proposed Section 643.001(4), Transportation Code (introduced version, page 849, line 5), strike "10102" and substitute "13102".

(9) In Section 30.150(a) of the bill, proposed Section 643.153(a), Transportation Code (introduced version, page 858, line 24), strike "1056" and substitute "375".

On certification, the court shall adopt a special budget for the limited purpose of spending the revenue from intergovernmental contracts for its intended purpose.

SECTION 7. Subchapter B, Chapter 111, Local Government Code, is amended by adding Section 111.045 to read as follows:

Sec. 111.045. SPECIAL BUDGET FOR REVENUE FROM INTERGOVERNMENTAL CONTRACTS. The county auditor shall certify to the commissioners court the receipt of all revenue from intergovernmental contracts that is available for disbursement in a fiscal year but not included in the budget for that fiscal year. On certification, the court shall adopt a special budget for the limited purpose of spending the revenue from intergovernmental contracts for its intended purpose.

SECTION 8. Subchapter C, Chapter 111, Local Government Code, is amended by adding Section 111.708 to read as follows:

Sec. 111.708. SPECIAL BUDGET FOR REVENUE FROM INTERGOVERNMENTAL CONTRACTS. The county auditor shall certify to the commissioners court the receipt of all revenue from intergovernmental contracts that is available for disbursement in a fiscal year but not included in the budget for that fiscal year. On certification, the court shall adopt a special budget for the limited purpose of spending the revenue from intergovernmental contracts for its intended purpose.

(3) Renumber the remaining SECTIONS accordingly.

(1) owned or otherwise effectively controlled by the owners or operators of the particular industrial plant, manufacturing plant, mining operation, or agricultural operation from which the waste results or is produced; and

(2) only in the case of disposal, located within 50 miles from plant or operation that is the source of the industrial solid waste.

**PERMISSION TO INTRODUCE BILLS**

On motion of Senator Truan and by unanimous consent, Article III, Section 5 of the Texas Constitution and Senate Rule 7.07(b) were suspended to permit the introduction of the following bills:

**SENATE BILL 500 ON SECOND READING**

On motion of Senator Zaffirini and by unanimous consent, the regular order of business was suspended to take up for consideration at this time on its second reading and passage to engrossment:

**SB 500**, Relating to the contents of a voter registration application.

The bill was read second time.

Senator Zaffirini offered the following committee amendment to the bill:

**Committee Amendment No. 1**

Amend **SB 500**, by adding a new SECTION 1, to read as follows, and renumber the remaining sections accordingly:

SECTION 1. Section 16.031(a), Election Code, is amended to read as follows:

(a) The registrar shall cancel a voter's registration immediately on receipt of:

(1) notice under Section 13.072(b) or 15.021 or a response under Section 15.053 that the voter's residence is outside the county;

(2) an abstract of the voter's death certificate under Section 16.001(a) or an abstract of an application indicating that the voter is deceased under Section 16.001(b);

(3) an abstract of a final judgment of the voter's mental incompetence, conviction of a felony, or disqualification under Section 16.002, 16.003, or 16.004;

(4) notice under Section 112.012 that the voter has applied for a limited ballot in another county; [or]

(5) notice from a voter registration official in another state that the voter has registered to vote outside this state; or

(6) notice from the secretary of state that a person with the same name and driver's license number or the same social security number has subsequently registered in another county in the state.

The committee amendment was read and was adopted by a viva voce vote.

Senator Zaffirini offered the following committee amendment to the bill:

**Committee Amendment No. 2**

Amend **SB 500** as follows:

**SENATE BILL 892 ON SECOND READING**

On motion of Senator Ellis and by unanimous consent, the regular order of business was suspended to take up for consideration at this time on its second reading and passage to engrossment:

**SB 892**, Relating to the formation of a commission to study issues relating to the consolidation of local governments.

The bill was read second time.

**Committee Amendment No. 1**

Amend **SB 892** at the end of SECTION 1 of the bill (introduced version, page 3, between lines 19 and 20), by inserting the following:

(m) The University of Texas at San Antonio shall provide the staff and support necessary to administer this Act.

The committee amendment was read and was adopted by a viva voce vote.

Senator Ellis offered the following committee amendment to the bill:

**Committee Amendment No. 2**

Amend **SB 892** in SECTION 1 of the bill by striking Subsection (h) (introduced version, page 2, lines 12 and 13) and substituting the following:

(h) The University of Texas at San Antonio shall reimburse, as provided by the General Appropriations Act, the travel expenses incurred in conducting the business of the commission by a member of the commission who is not a state official, member of the governing body of a municipality, or a member of a commissioners court.

The committee amendment was read and was adopted by a viva voce vote.

**SB 892** as amended was passed to engrossment by a viva voce vote.

Senator Nelson asked to be recorded as voting "Nay" on the passage of the bill to engrossment.

**SENATE BILL 892 ON THIRD READING**

Senator Ellis moved that Senate Rule 7.18 and the Constitutional Rule requiring bills to be read on three several days be suspended and that **SB 892** be placed on its third reading and final passage.

The motion prevailed by the following vote: Yeas 30, Nays 1.

**SB 892** was read third time and was passed by a viva voce vote.

The Commissioner of Education shall grant exemptions upon written request by the school district.

The committee amendment was read and was adopted by a viva voce vote.

**SB 433** as amended was passed to engrossment by a viva voce vote.
