**HB 1387 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE HODGE: Representative, I understand the unfunded mandate, I'm opposed to that. I think the schools need local control, but more importantly, I am totally opposed to eminent domain. You're standing there saying two different things, using the same term.

REPRESENTATIVE P. KING: Okay.

HODGE: Originally, I thought this bill was to say if you decide you want to take a person's property through eminent domain, is that this feasibility study must be done before you do that.

P. KING: That's correct.

HODGE: But just a minute ago, sir, you said, "After it has been decided to take the property by eminent domain, then you have the—"

P. KING: Right. I'm sorry, I wasn't very clear. Typically the way it happens, they go out and they try to negotiate with a property owner and try to buy the land. They don't have to do a feasibility study to do that. But once the board makes the decision that they're going to file an eminent domain suit, before they actually do the eminent domain, actually do the forceful taking, that's when they have to do the feasibility study, but not until then.

HODGE: Mr. Speaker, I would like the conversation between me and the representative to be placed in the journal, because I really want to understand that what you're trying to do is to not have property taken by eminent domain if the property has not been proven to be necessary property to take.

P. KING: Yes, ma'am, that's exactly what I'm trying to do. If they're just buying land, until they start that eminent domain process, it's only necessary if they're going to exercise eminent domain. Otherwise they don't have to do it. Thank you for clarifying that.
