HB 483, A bill to be entitled An Act relating to an administrative fee for defendants required by a court to perform community service in lieu of serving a term of confinement in county jail.

HB 483 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE HODGE: I'm trying to make sure I'm understanding, as a follow-up to what he asked. When you are in jail, you have either been accused of something, waiting to go to trial, or you've been maybe convicted, waiting to move to the next steps. The person that we're talking about in this bill, that would be charged with paying community service, have they been to trial and been convicted yet?

REPRESENTATIVE PIERSON: Yes, they could have been convicted. They could have gotten a traffic ticket, for instance, and been convicted, and said, "you have to serve a week in jail, or three weekends for community service." It's one or the other, and this allows them to be able to go and do the community service, not sit in jail and lose their jobs. But they still get the community service. It's a punishment—it's in lieu of.

HODGE: Here's where I'm a little confused, because what I'm going to assume is that you say it's not probation that the judge has charged me with, but what they have charged me is a \$75 fine. So rather than me sit in jail and pay this fine, they're going to allow me to do community service?

PIERSON: That is correct.

HODGE: And in order for me to do community service, I gotta buy that. I gotta buy community service by paying this \$50?

PIERSON: No ma'am. It's a sliding scale, and if you're indigent and can't afford the fee, you can sit in jail if you want, or it can be free. If you're truly indigent, I doubt that they'll charge the fee if you can prove that you're indigent. If you're not indigent and you want to get out and do community service, then you will pay a fee up to, not to exceed, \$50 to pay for the program.

HODGE: So let me go back over that, I'm still confused. Are you saying that a person who is financially eligible to pay the \$50, they can pay that \$50 and then be released to do community service?

PIERSON: That is correct.

HODGE: And on the other side of that, though, the indigent person—this sliding scale fee, I'm assuming, that can be from \$1 up to \$50.

PIERSON: It could be from \$0 up to \$50. They might not even have to pay \$1.

HODGE: So a person who is indigent, then, can also be given the opportunity to do the same community service, but don't have to pay anything?

PIERSON: That is correct.

(a) If a person who is a current license holder moves from any residence [~~the~~] address stated on the license [~~to a new residence address~~], if the name of the person is changed by marriage or otherwise, or if the person's status [~~as a judge, justice, district attorney, prosecuting attorney, or assistant prosecuting attorney, as a federal judge, a state judge, or the spouse of a federal judge or state judge,~~] becomes inapplicable for purposes of the information required to be displayed on the license under Section 411.179 [~~411.179(c)~~], the person shall, not later than the

30th day after the date of the address, name, or status change, notify the department and provide the department with the number of the person's license and, as applicable, the person's:

- (1) former and new addresses; ~~[or]~~
- (2) former and new names; or
- (3) former and new status.

(b) If the name of the license holder is changed by marriage or otherwise, or if the person's status ~~[as a federal judge or state judge, or the spouse of a federal judge or state judge]~~ becomes inapplicable as described by Subsection (a), the person shall apply for a duplicate license. The duplicate license must reflect ~~[include]~~ the person's current name, residence address, and status.

SECTION _____. Section 411.187(a), Government Code, is amended to read as follows:

(a) A license may be suspended under this section if the license holder:

- (1) is charged with the commission of a Class A or Class B misdemeanor or an offense under Section 42.01, Penal Code, or of a felony under an information or indictment;
- (2) fails to display a license as required by Section 411.205;
- (3) fails to notify the department of a change of address, ~~[or]~~ name, or status as required by Section 411.181;
- (4) carries a concealed handgun under the authority of this subchapter of a different category than the license holder is licensed to carry;
- (5) fails to return a previously issued license after a license is modified as required by Section 411.184(d);
- (6) commits an act of family violence and is the subject of an active protective order rendered under Title 4, Family Code; or
- (7) is arrested for an offense involving family violence or an offense under Section 42.072, Penal Code, and is the subject of an order for emergency protection issued under Article 17.292, Code of Criminal Procedure.
