**HB 3545 ON SECOND READING**

**HB 3545**, A bill to be entitled An Act relating to nonsubstantive additions to and corrections in enacted codes, to the nonsubstantive codification or disposition of various laws omitted from enacted codes, to conforming codifications enacted by the 80th Legislature to other Acts of that legislature, and to the repeal of certain unconstitutional laws.

Representative Pitts offered the following amendment to **HB 1487**:

Amend **HB 1487**, House Committee Report, as follows:

Page 1, line 16, STRIKE Subsection (b) and substitute the following Subsection (b) to read as follows:

(b) To the extent practicable, and in conformity with Chapter 157, Occupations Code, and Chapter 483, Health and Safety Code, after conducting a review under Subsection (a) the commission shall modify only forms, rules, and procedures applicable to orders for diabetic equipment and supplies under the Medicaid program to provide for an ordering system that is comparable to the

ordering system for diabetic equipment and supplies under the Medicare program. The ordering system must permit a diabetic equipment or supplies supplier to complete the forms by hand or to enter by electronic format medical information or supply orders into any form as necessary to provide the information required to dispense diabetic equipment or supplies.

Amendment No. 1 was adopted.

**CSHB 1634 ON SECOND READING  
(by T. Smith)**

**CSHB 1634**, A bill to be entitled An Act relating to the release of a motor vehicle accident report or certain information in a motor vehicle accident report; providing penalties.

**Amendment No. 1**

Representative T. Smith offered the following amendment to **CSHB 1634**:

Amend **CSHB 1634** as follows:

(1) On page 1, between lines 23 and 24, insert the following:

(b-1) Vehicle specific, nonpersonally identifiable information is exempted from exclusion and may be released immediately, if the person requesting the information provides the agency with a written statement averring that the information and any information subsequently requested by the person from the

agency will not be used in connection with a commercial solicitation of a person involved in an accident or knowingly disclosed to a third person for the purpose of making a commercial solicitation of a person involved in an accident.

(2) On page 5, line 6, between "contract" and "and", insert "or a letter from the insurer that authorizes the obtaining of the report or information for insurance purposes only".

Amendment No. 1 was adopted.

**CSHB 1634**, as amended, was passed to engrossment.

**CSHB 1474 ON SECOND READING**  
**(by Geren)**

**CSHB 1474**, A bill to be entitled An Act relating to the operation and regulation of charitable bingo and the use of bingo proceeds.

**Amendment No. 1**

Representative Geren offered the following amendment to **CSHB 1474**:

Amend **CSHB 1474** as follows:

1. Strike page 2, line 10 through page 3, line 5.
2. Strike page 11, line 27 through page 12, line 1 and insert:

"(4) there is no diversion of the funds of the proposed lessee from the lawful purposes under this chapter;"

3. On page 25, line 24, strike "and pull-tab bingo tickets"
4. On page 34, strike SECTION 39 of the bill
5. On page 37, strike line 17
6. On page 37, strike line 19
7. On page 37, strike line 22

**HB 1058 ON SECOND READING**  
**(by Solomons)**

**HB 1058**, A bill to be entitled An Act relating to the receipt of death benefits in the workers' compensation system.

**Amendment No. 1**

Representative Solomons offered the following amendment to **HB 1058**:

Amend **HB 1058** (House committee printing) by striking page 1, lines 5-6, and substituting the following:

SECTION 1. Sections 408.182(d-1), (d-2), and (f), Labor Code, are amended to read as follows:

(d-1) If there is no eligible spouse, no eligible child, and no eligible grandchild, and there are no surviving dependents of the deceased employee who are parents, siblings, or grandparents of the deceased, the death benefits shall be paid in equal shares to surviving eligible parents of the deceased. A payment of



death benefits made under this subsection may not exceed one payment per household. Total payments under this section [and] may not exceed 104 weeks regardless of the number of surviving eligible parents.

Amendment No. 1 was adopted.

**HB 1058**, as amended, was passed to engrossment.

**HB 1995 ON SECOND READING**  
**(by McCall and Button)**

**HB 1995**, A bill to be entitled An Act relating to the liability of volunteer audiologists and speech-language pathologists who provide certain speech, language, and hearing evaluations.

**HB 1995** was passed to engrossment.

**CSHB 461 ON SECOND READING**  
**(by Eissler, Chisum, and Button)**

**CSHB 461**, A bill to be entitled An Act relating to the detection and treatment of dyslexia, including the use of certain professional titles by dyslexia practitioners and therapists; providing a criminal penalty.

Representative Eissler moved to postpone consideration of **CSHB 461** until 10 a.m. Monday, May 4.

**HB 796 ON SECOND READING**  
**(by T. Smith)**

**HB 796**, A bill to be entitled An Act relating to the disposition of property alleged to have been illegally acquired and to the use of the photographic evidence of that property in a criminal action.

**HB 796** was passed to engrossment.

**HB 548 ON SECOND READING**  
**(by Pickett)**

**HB 548**, A bill to be entitled An Act relating to the impoundment of certain motor vehicles involved in the commission of the offense of racing on a highway.

**Amendment No. 1 (Committee Amendment No. 1)**

Representative Pickett offered the following committee amendment to **HB 548**:

Amend **HB 548** as follows:

(1) On page 1, lines 10-12, strike "garage or to a garage designated or maintained by the governmental agency that employs the officer" and substitute "licensed vehicle storage facility".

Amendment No. 1 was adopted.

**HB 548**, as amended, was passed to engrossment.

**HB 1433 ON SECOND READING**  
**(by Lucio)**

**HB 1433**, A bill to be entitled An Act relating to the amount of the annual water quality fee imposed on holders of wastewater discharge permits and on users of water.

(D. Miller now present)

**Amendment No. 1**

Representative Lucio offered the following amendment to **HB 1433**:

Amend **HB 1433** (House committee printing) on page 1 by striking lines 8-12 and substituting:  
 determining the amount of the fee to be charged. Beginning September 1, 2009, the maximum amount of a fee under this section is \$100,000. On September 1 of each subsequent year, the commission shall adjust the maximum fee amount as necessary to reflect the percentage change during the preceding year in the Consumer Price Index for All Urban Consumers (CPI-U), U.S. City Average, published monthly by the United States Bureau of Labor Statistics, or its successor in function. Notwithstanding any adjustment for inflation under this subsection, the [The] amount of the fee may not exceed \$150,000 [may not exceed \$75,000] for each permit or contract and the [-The] maximum annual fee under this section for a wastewater discharge or waste treatment facility that holds a water right for the use of water by the facility is \$150,000 [may not exceed \$75,000].

Amendment No. 1 was adopted.

**HB 1433**, as amended, was passed to engrossment. (Berman, B. Brown, Button, Christian, Kent, Marquez, D. Miller, Phillips, Pierson, Riddle, and C. Turner recorded voting no.)

**CSHB 428 ON SECOND READING**  
 (by Castro)

**CSHB 428**, A bill to be entitled An Act relating to standing for certain individuals to file a suit affecting the parent-child relationship.

**CSHB 428** was passed to engrossment.

**CSHB 646 ON SECOND READING**  
 (by Hughes)

**CSHB 646**, A bill to be entitled An Act relating to the participation of this state in the Southern High-Speed Rail Compact.

**Amendment No. 1**

Representative Hughes offered the following amendment to **CSHB 646**:

Amend **CSHB 646** (House Committee Printing) by striking page 2, line 21, through page 3, line 13, and substituting:

(b) The membership of the commission consists of:

(1) the governor of each party state or that governor's designee;

(2) one representative each from:

(A) the Mississippi Energy and Transportation Board, or its successor;

(B) the Office of Aviation and Public Transportation of the Louisiana Department of Transportation and Development, or its successor;

(C) the Alabama Department of Energy, or its successor; and

(D) the Texas Department of Transportation; and

(3) five citizens from each party state, appointed by the governor of the party state.

(c) The citizens appointed from the state of Texas must reside in a federally designated high-speed rail corridor.

(d) An appointed member of the commission serves a four-year term.

(e) A vacancy on the commission shall be filled for the unexpired portion of the term by the governor of the party state that appointed the member whose position becomes vacant.

(f) A member is not entitled to compensation for service on the commission but is entitled to reimbursement for reasonable expenses the member incurs in performing commission duties.

Amendment No. 1 was adopted.

**CSHB 646**, as amended, was passed to engrossment.

**CSHB 453 ON SECOND READING**  
**(by Gonzalez Toureilles and T. King)**

**CSHB 453**, A bill to be entitled An Act relating to the use of auction proceeds from the sale of certain abandoned motor vehicles to compensate certain property owners.

**Amendment No. 1**

Representative Gonzalez Toureilles offered the following amendment to **CSHB 453**:

Amend **CSHB 453** (house committee report) on page 1, line 24, between "consideration" and "at the next", by inserting ", and the commissioners court shall consider the proposed payment for compensation,".

Amendment No. 1 was adopted.

**Amendment No. 2**

Representative Gonzalez Toureilles offered the following amendment to **CSHB 453**:

Amend **CSHB 453** (house committee report) on page 1, line 7, between "A" and "law enforcement", by inserting "county".

Amendment No. 2 was adopted.

**CSHB 453**, as amended, was passed to engrossment.

**HB 2664 ON SECOND READING**  
**(by Ritter)**

**HB 2664**, A bill to be entitled An Act relating to creating a defense to prosecution for the offense of unlawful carrying of a handgun by a license holder on the premises of certain businesses.

**HB 2664** was passed to engrossment.

**HB 2276 ON SECOND READING**  
**(by Hunter)**

**HB 2276**, A bill to be entitled An Act relating to the use of state hotel occupancy tax revenue to clean and maintain beaches in certain municipalities.

**HB 2276** was passed to engrossment.

**HB 140 ON SECOND READING**

(by Gonzalez Toureilles, Homer, Hughes, Kleinschmidt, Paxton, et al.)

**HB 140**, A bill to be entitled An Act relating to the use or display under certain circumstances of an expired license to carry a concealed handgun.

**HB 140** was passed to engrossment.

**HB 410 ON SECOND READING**

(by Isett, Homer, Legler, Eiland, Harper-Brown, et al.)

**HB 410**, A bill to be entitled An Act relating to the requirement under certain circumstances that a license holder display their license to carry a concealed handgun.

**Amendment No. 1**

Representative Guillen offered the following amendment to **HB 410**:

Amend **HB 410** (house committee printing) by adding the following appropriately numbered SECTIONS to the bill and renumbering subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Subchapter H, Chapter 411, Government Code, is amended by adding Section 411.2055 to read as follows:

Sec. 411.2055. LIMITATION ON PROVISION OF LICENSING INFORMATION TO PEACE OFFICER. The department by rule shall establish a procedure by which a peace officer who provides the department with a person's driver's license number, personal identification certificate number, or vehicle license plate number as part of a motor vehicle stop or other law enforcement inquiry is prohibited from receiving information from the department as to whether the person is the holder of a license issued under this subchapter unless the officer indicates that information is necessary for proper law enforcement purposes related to the person's possession or carrying of a handgun.

REPRESENTATIVE PATRICK: Yes, thank you.

GUTIERREZ: My concern is—and I think I'm okay with this bill—my concern is that this information would not be subject to being disseminated publicly, but rather just simply to the parties in the court, within the court itself, correct?

PATRICK: Correct. The law already restricts the use of these records if a judge orders them to be released. They can be used only for the purposes that are consistent with the Family Code and applicable federal or state laws on CPS rules. Thank you for bringing that to our attention.

GUTIERREZ: Yes, Representative Patrick, and the reason for it is that we have a criminal system and we have a civil system where the FPS can go in there and take the children and get them away from this neglect. My concern is the abuse of a system where something may or may not happen that never rose to that level, to that secondary level—that primary level, rather. So with that in mind, I think that the bill is okay.

- (1) suitable civilian clothing;
- (2) money held in the inmate's trust account by the director; [~~and~~]
- (3) cash, in an amount and in the manner described by Subsection (b);

(4) a personal identification certificate obtained under Section 501.0165, if available.

SECTION 2. Subchapter A, Chapter 501, Government Code, is amended by adding Section 501.0165 to read as follows:

Sec. 501.0165. STATE-ISSUED IDENTIFICATION; NECESSARY DOCUMENTATION. (a) Before discharging an inmate or releasing an inmate on parole, mandatory supervision, or conditional pardon, the department shall:

(1) determine whether the inmate has:

(A) a valid license issued under Chapter 521 or 522, Transportation

Code; or

(B) a valid personal identification certificate issued under Chapter 521, Transportation Code; and

(2) if the inmate does not have a valid license or certificate described by Subdivision (1), submit to the Department of Public Safety on behalf of the inmate a request for the issuance of a personal identification certificate under Chapter 521, Transportation Code.

(b) The department shall submit a request under Subsection (a)(2) as soon as is practicable to enable the department to provide the inmate with the personal identification certificate when the department discharges or releases the inmate.

(c) The department, the Department of Public Safety, and the bureau of vital statistics of the Department of State Health Services shall by rule adopt a memorandum of understanding that establishes their respective responsibilities with respect to the issuance of a personal identification certificate to an inmate, including responsibilities related to verification of the inmate's identity.

(d) The department shall reimburse the Department of Public Safety or the Department of State Health Services for any costs incurred by those agencies in performing responsibilities established under this section.

(e) This section does not apply to an inmate who:

(1) is not legally present in the United States; or

(2) was not a resident of this state before the person was placed in the custody of the department.

SECTION 3. This Act takes effect September 1, 2009.

(b) A person subject to this section shall notify the department of the change not later than the 30th day after the date on which the change takes effect and apply for a duplicate license or certificate as provided by Section 521.146. The duplicate license must include the person's current residence address.
