CANVASSING THE VOTES CAST FOR GOVERNOR AND LIEUTENANT GOVERNOR (The House of Representatives and Senate in Joint Session)

In accordance with the provisions of **SCR 6** providing for a joint session of the house and senate for the purpose of counting the votes for the governor of Texas and the lieutenant governor of Texas cast at the general election, held on November 8, 2022, the honorable senators, at 10:59 a.m., were admitted to the hall of the house and occupied seats arranged for them.

President pro tempore Hancock was escorted to the speaker's rostrum and called the senate to order.

Speaker Phelan called the house of representatives to order at 11:07 a.m.

Speaker Phelan stated that the house and senate were in joint session pursuant to **SCR 6** for the purpose of counting the votes for governor of Texas and lieutenant governor of Texas cast at the last general election, held on November 8, 2022.

JOINT COMMITTEE APPOINTED

The speaker announced the appointment of the following joint committee of tellers to count the votes cast for governor and lieutenant governor: Senators Flores, chair; King, LaMantia, Middleton, Parker, and Sparks on the part of the senate; and Representatives Darby, chair; Ashby, Cook, A. Johnson, E. Morales, and Spiller on the part of the house.

The joint tellers were announced present.

Speaker Phelan made the following announcement:

Pursuant to the Texas Constitution and laws of the State of Texas, as speaker of the house of representatives, I now officially turn over to the joint committee the official returns of the last general election, held November 8, 2022, for the office of governor and for the office of lieutenant governor of Texas, said returns having been turned over to me by the Honorable Jane Nelson, secretary of state.

JOINT SESSION AT EASE

At 11:10 a.m., the speaker announced that the joint session would stand at ease pending the receipt of the report of the joint committee of tellers.

REPORT OF THE JOINT COMMITTEE TO CANVASS VOTES CAST FOR GOVERNOR AND LIEUTENANT GOVERNOR

Speaker Phelan stated that the joint tellers had completed the count of the votes and the legislature was now ready to receive the results and the report of the joint tellers. The report was read, as follows:

We, the joint committee appointed by the presiding officers of the Senate and House of Representatives to canvass the votes cast at the last general election held in the State of Texas on November 8, 2022, for Governor and Lieutenant Governor of the State of Texas, as shown by returns delivered to us by the secretary of state, beg leave to report that we have performed that duty and that the result of our canvass is as follows:

The Honorable Greg Abbott having received the highest number of votes cast, I, by virtue of the authority vested in me by the Constitution and the laws of the State of Texas, declare him duly, legally, and constitutionally elected governor of the State of Texas for the ensuing term of four years.

The Honorable Dan Patrick having received the highest number of votes cast, I, by virtue of the authority vested in me by the Constitution and the laws of the State of Texas, declare him duly, legally, and constitutionally elected lieutenant governor of the State of Texas for the ensuing term of four years.

Speaker Phelan delivered the official returns of the election to the secretary of state.

At 12:24 p.m., the president pro tempore stated that the purpose for which the joint session was called had been completed and the senate would, in accordance with a previous motion, stand recessed until 11 a.m. Tuesday, January 17.
