### **PROCLAMATION BY THE SPEAKER CREATION OF HOUSE SELECT COMMITTEE ON COMMUNITY SAFETY**

Pursuant to Rule 1, Section 16(b), Rules of the House of Representatives, I, Dade Phelan, Speaker of the House of Representatives, hereby create the House Select Committee on Community Safety.

#### **SECTION 1. PURPOSE AND JURISDICTION.**

The committee has jurisdiction over all matters pertaining to community safety related to:

- (1) the possession, use, sale, and transfer of firearms and ammunition; and
- (2) associated criminal offenses and penalties.

#### **SECTION 2. MEMBERSHIP, AUTHORITY, AND DURATION.**

The committee shall have 13 members and shall have the same authority and duties conferred on standing committees under the Rules of the House of Representatives. The committee expires on the date the 89th Legislature convenes.
