**HJR 90** (By Campos), Proposing a constitutional amendment authorizing the issuance of general obligation bonds to provide funding for the construction, expansion, maintenance, and operation of state mental health facilities.

To Pensions, Investments, and Financial Services.

**HJR 91** (By Canales), Proposing a constitutional amendment to direct the legislature to authorize and regulate the possession, cultivation, and sale of cannabis.

To State Affairs.

**HJR 92** (By Raymond), Proposing a constitutional amendment to dedicate net state lottery revenue to support educational programs that benefit classroom teaching in public schools and to prohibit advertisements and promotions that state or imply lottery ticket sales revenue will financially assist public schools.

To Appropriations.

**HJR 93** (By Raymond), Proposing a constitutional amendment authorizing local option elections to legalize or prohibit the operation of eight-liners or similar gaming devices; authorizing a fee.

To State Affairs.

**HJR 94** (By Cunningham), Proposing a constitutional amendment authorizing the legislature to set a minimum amount of monetary bond for persons charged with certain felony offenses involving violence and requiring the denial of bail to a person accused of committing a felony while released on bail for a prior felony under most circumstances.

To Criminal Jurisprudence.

**HJR 95** (By Leach), Proposing a constitutional amendment to authorize the legislature to set a lower limit on the maximum appraised value of a residence homestead for ad valorem taxation.

To Ways and Means.

**HJR 96** (By Talarico), Proposing a constitutional amendment authorizing the legislature to exempt from ad valorem taxation real property used to operate a child-care facility.

To Ways and Means.

**HJR 97** (By Geren and Kuempel), Proposing a constitutional amendment to foster economic development and job growth, provide tax relief and funding for education and public safety programs, and reform and support the horse racing industry by authorizing casino gaming at destination resorts, creating the Texas Gaming Commission, authorizing sports wagering, requiring a license to conduct casino gaming, and requiring the imposition of a gaming and sports wagering tax and license application fees.

**HJR 98** (By Tinderholt), Proposing a constitutional amendment specifying the authority of the attorney general to prosecute a criminal offense prescribed by the election laws of this state.

**HJR 99** (By Stucky), Proposing a constitutional amendment requiring the denial of bail to certain persons arrested for an offense resulting in the death of or serious bodily injury to a person younger than 18 years of age.

To Criminal Jurisprudence.

**HJR 100** (By Rogers), Proposing a constitutional amendment authorizing a statewide referendum allowing voters to indicate a preference for observing standard time year-round or observing daylight saving time year-round.

**HJR 101** (By Rogers), Proposing a constitutional amendment authorizing the legislature to exempt from ad valorem taxation income-producing tangible personal property having a value of less than a certain amount.

To Ways and Means.

**HJR 102** (By Leach), Proposing a constitutional amendment authorizing the legislature to legalize wagering in this state on certain sporting events.

**HJR 103** (By Klick), Proposing a constitutional amendment providing procedures to fill a vacancy in the office of Speaker of the House of Representatives.

To House Administration.

**HJR 104** (By Raney), Proposing a constitutional amendment to authorize the legislature to exempt from ad valorem taxation a percentage of the market value of the tangible personal property a person owns that consists of inventory held for sale at retail.

**HJR 105** (By Dutton), Proposing a constitutional amendment authorizing the operation of five casinos in this state by licensed persons in certain counties that have approved casino gaming to provide funding for public education; providing for the requirement of occupational licenses, the authorization of fees, the imposition of a tax, and the provision of criminal penalties.

**HJR 106** (By Schaefer), Proposing a constitutional amendment recognizing the right of a person to travel in a vehicle using human decision-making to operate the vehicle.

**HJR 107** (By Price), Proposing a constitutional amendment to increase the mandatory age of retirement for state justices and judges.

**HJR 108** (By V. Jones), Proposing a constitutional amendment authorizing the commissioners court of a county to adopt an exemption from ad valorem taxation by the county of a portion, expressed as a dollar amount, of the appraised value of an individual's residence homestead.

**HJR 109** (By Burns), Proposing a constitutional amendment to abolish the office of county treasurer of Somervell County.
