What started with two cans of corn and the words of Dr. Martin Luther King Jr., may we "have the audacity to believe that people everywhere can have three meals a day for their bodies, education and culture for their minds, and dignity, equality, and freedom for their spirits," has blossomed into a larger organization nonprofit named after Dr. Jackson's mother, the late Dr. Minnie Hawthorne-Ewing.

With 12 locations and partnerships in Plano and McKinney to provide dinners for hungry children and families, a boutique, a storefront, financial literacy, and professional workshops, Minnie's Food Pantry kept their doors open throughout the pandemic working double time to meet the needs of North Texas communities. Everyone is greeted with a famous warm hug and more than 21 million healthy meals have been served to children and families in House District 70 and surrounding North Texas communities. Dr. Cheryl Jackson, a young Black woman who grew up on Prosperity Drive, is teaching us a better way to serve and understand how to feed the hungry and recognize that it doesn't matter what kind of house we have in our neighborhoods, hunger is everywhere.
