**HJR 155** (By Geren), Proposing a constitutional amendment to foster economic development and job growth, provide tax relief and funding for education and public safety programs, support the horse racing industry, and reform horse racing and greyhound racing by authorizing casino gaming at destination resorts, creating the Texas Gaming Commission, authorizing sports wagering, requiring a license to conduct casino gaming, requiring the imposition of casino gaming and sports wagering taxes, requiring license application fees, and authorizing Tribal-State compacts related to gaming.

To State Affairs.

**HJR 156** (By M. González), Proposing a constitutional amendment to require the governor to negotiate and execute gaming compacts with the Alabama-Coushatta Tribe of Texas, the Kickapoo Traditional Tribe of Texas, and the Ysleta del Sur Pueblo and to authorize those tribes to sue this state if the governor fails to negotiate in good faith.

**HJR 157** (By Guillen), Proposing a constitutional amendment to authorize the legislature to exempt from ad valorem taxation the portion of the assessed value of a person's property that is attributable to the installation or construction in or on the property of border security infrastructure.

**HJR 158** (By Cook), Proposing a constitutional amendment authorizing the legislature to exempt from ad valorem taxation income-producing tangible personal property having a value of less than a certain amount.

To Ways and Means.

**HJR 159** (By Cook), Proposing a constitutional amendment authorizing the legislature to exempt from ad valorem taxation a mineral interest that has a value of less than a certain amount.

To Ways and Means.

**HJR 160** (By Cook), Proposing a constitutional amendment to authorize the legislature to set a lower limit on the maximum appraised value of a residence homestead for ad valorem taxation.

To Ways and Means.

**HJR 161** (By Cook), Proposing a constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation by a political subdivision located wholly or partly in a populous county of a specified dollar amount, or a greater dollar amount specified by the governing body of the political subdivision, of the assessed value of a residence homestead.

To Ways and Means.

**HJR 162** (By Schofield), Proposing a constitutional amendment providing for an exemption from ad valorem taxation for public school purposes of a dollar amount or a percentage, whichever is greater, of the market value of a residence homestead and providing for an adjustment of the limitation on the total amount of ad valorem taxes that may be imposed for those purposes on the homestead of a person who is elderly or disabled to reflect increases in the exemption amount.

To Ways and Means.

**HJR 163** (By Harrison), Proposing a constitutional amendment allowing the voters to remove local elected officers from office by means of a recall election.

To State Affairs.

**HJR 164** (By Harrison), Proposing a constitutional amendment excepting certain appropriations to pay for tax relief from the constitutional limitation on the rate of growth of appropriations.

To Appropriations.

**HJR 165** (By Muñoz), Proposing a constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a military service member who is killed or fatally injured in the line of duty.

To Ways and Means.

**HJR 166** (By S. Thompson), Proposing a constitutional amendment allowing recovery of exemplary damages by a person's estate for a homicide.

To Judiciary and Civil Jurisprudence.

**HJR 167** (By J. Lopez), Proposing a constitutional amendment increasing the amount of additional general obligation bonds that may be issued by the Texas Water Development Board to provide financial assistance for the development of certain projects in economically distressed areas.

To Natural Resources.

**HJR 168** (By Turner), Proposing a constitutional amendment to limit the rate of a state sales or use tax.

To Ways and Means.

**HJR 169** (By Clardy), Proposing a constitutional amendment providing for the dedication of certain sales and use tax revenue to a special fund established in the state treasury to pay for water infrastructure in this state.

To Natural Resources.

**HJR 170** (By K. King), Proposing a constitutional amendment creating the State School Safety Fund to provide financial support for projects that enhance the safety of schools in this state.

To Select Youth Health and Safety.

**HJR 171** (By Button), Proposing a constitutional amendment establishing a limitation on the total amount of ad valorem taxes that a county may impose on the residence homesteads of persons who are disabled or elderly and their surviving spouses.

To Ways and Means.

**HJR 172** (By Cook), Proposing a constitutional amendment authorizing the legislature to enact laws providing for a court to grant a commutation of punishment to certain individuals serving a term of imprisonment.
