BACKGROUND:	HB 970 by Truitt, which was signed by the governor on May 15 and became effective immediately, amended Local Government Code, sec. 263.152(a) to authorize a county commissioners court to donate surplus or salvage property to civic or charitable organizations in the county without first offering the property for sale. The court first must determine that:

property, other than items routinely discarded as waste, that because of use, time, accident, or any other cause is so worn, damaged, or obsolete that it has no value for the purpose for which it was originally intended. Surplus property is property that might still serve a useful purpose, but is of no use for the current or foreseeable future needs of its owner. Health and Safety Code, ch. 285 governs special provisions relating to hospital districts. Currently, there is no statutory provision to allow hospital districts to dispose of surplus or salvage property that might include carpet, window shades, office furniture, cafeteria dishes, or other items that, while worn or broken, might be of use to small, grassroots civic and charitable organizations. DIGEST: CSSB 705 would add subch. Z to Health and Safety, ch. 285, authorizing the governing board of a hospital districts to dispose of salvage and surplus property in the same way that a commissioners court of a county may dispose of the county's surplus and salvage property under Local Government Code, sec. 263.152. This bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2003. NOTES: The companion bill, HB 970 by Truitt, which did not include authorization for hospital districts to donate surplus and salvage property to civic and charitable organizations, was signed by the governor on May 15 and became effective immediately.
