BACKGROUND:	Occupations Code Sec. 453.301(a-1) states a physical therapist may treat a patient for not more than 10 consecutive business days without a referral under certain circumstances. Under sec. 453.301 (a-2), a physical therapist may treat a patient for 15 consecutive business days or less without a referral if the physical therapist possesses a doctoral degree in physical therapy from an accredited program and either has completed a residency fellowship or is certified by the Texas Board of Physical Examiners.		

Some have suggested extending the number of days a physical therapist may see a patient without a referral to allow patients to choose the

treatment they believe meets their needs.

DIGEST: CSHB 2553 would extend the number of consecutive business days a physical therapist could treat a patient without a referral from 10 to 20 consecutive business days. The bill would repeal Occupations Code sec. 453.301(a-2).

By December 1, 2023, the Texas Board of Physical Examiners would be required to adopt rules necessary to implement the provisions of the bill.

The bill would take effect September 1, 2023.
