BACKGROUND: Some have suggested granting the Texas Workforce Commission (TWC)

the authority to certify industry-recognized apprenticeship programs could

help create more apprenticeship opportunities in Texas.

DIGEST: CSHB 4411 would create new regulations and alternatives for current

apprenticeship initiatives.

Pre-apprenticeship program. CSHB 4411 would require TWC by rule to establish procedures and standards by which TWC could allocate funds available for the support of apprenticeship training programs. The funds would be designated to support pre-apprenticeships designed for high school students enrolled in career and technical education programs of study leading to employment in high-wage, high-demand occupations. The standards would have to:

- be developed in coordination with the Texas Education Agency or Texas Higher Education Coordinating Board;
- align with the tri-agency strategic framework; and
- ensure that any committee overseeing a pre-apprenticeship be comprised of certain relevant individuals.

TWC would publish wage outcome data for apprentices who completed an apprenticeship training program on its website.

Rules and regulations. TWC would establish certain rules regarding the apprenticeship system of adult career and technology education including:

- which occupations are recognized by TWC as an apprenticeable occupation based on a specific criteria;
- standards of apprenticeship for particular trades; and
- a process for and the criteria by which TWC could certify a training or apprenticeship program as an industry-recognized apprenticeship program.

The bill would revise the definition for "apprenticeship training program" to reflect these changes and allow the program to be certified by TWC as an industry-recognized apprenticeship program as an alternative to being both registered with the federal Office of Apprenticeship and approved by TWC. CSHB 4411 would allow for career and technical education programs of study to culminate in the attainment of an apprenticeship to be certified by TWC.

The bill would take effect September 1, 2023. As soon as practicable after

the effective date, TWC would be required to adopt the rules required to implement the bill.
