BACKGROUND:

Some have suggested that requiring state approval before holding an election to adopt a municipal climate charter could prevent the adoption of such charters that may increase energy costs or result in job losses.

DIGEST:

HB 4930 would require a municipality or charter commission to receive approval from the appropriate state agency with proper jurisdiction in order to propose the creation of a climate charter for a municipality or an amendment to a municipality's climate charter.

The bill would define "climate charter" as an overarching or comprehensive ordinance, rule, or other policy statement that addresses climate change or environmental impact on areas such as water, energy, and emissions.

Municipalities that have adopted a climate charter before the effective date of this bill would be required to comply with the approval requirements listed no later than January 1, 2025. A climate charter adopted before the effective date of the bill would remain valid and enforceable until January 1, 2026.

This bill would take effect September 1, 2023.
