BACKGROUND:

Concerns have been raised that hospitals may charge patients who pay in cash higher rates than insured patients for the same services.

DIGEST:

CSHB 633 would require a hospital to accept full payment directly from patients, including health benefit plan enrollees, for a health care service provided in the hospital at the patient's request. If an enrollee made a direct payment, the hospital would have to accept the payment in lieu of submitting a claim to the enrollee's health benefit plan. "Health benefit plan" would not include the Medicaid program, the Child's Heath Insurance Program, or Medicare benefits.

A patient would be required to make a request to pay the hospital directly within 60 days after receiving the health care service. Notwithstanding any other law, the amount of a direct payment could not exceed the lowest contracted rate for the health care service that the hospital had agreed to accept as payment in full as a contracted, preferred, or participating health benefit plan provider.

The bill would take effect September 1, 2023.

NOTES:

According to the Legislative Budget Board, CSHB 633 would have an indeterminate fiscal impact to the state due to the unknown number of individuals and health care providers that would participate in direct payment exchanges and health care providers that would voluntarily discontinue contracting with health insurance companies.
