**BACKGROUND:** 

Concerns have been raised about an expected increase in water demands due to Texas' rapidly growing population alongside a projected decline of existing water supplies.

DIGEST:

CSSJR would amend the Texas Constitution to create the Texas water fund as a special fund in the state treasury outside the general revenue fund. The fund would be administered by the Texas Water Development Board (TWDB) and could be used only to transfer money to other funds or accounts administered by TWDB. The resolution would authorize TWDB to restore to the fund money transferred from the fund. Legislative appropriation would not be required for TWDB to transfer money from or restore money to the fund. The fund would consist of:

- money from any source transferred or deposited to the credit of the fund by general law, including legislative appropriations;
- any other revenue that the Legislature by statute dedicated for deposit to the credit of the fund;

- investment earnings and interest earned on amounts credited to the fund;
- money from gifts, grants, or donations to the fund; and
- money returned from any authorized transfer.

Subject to limitations in the resolution, the Legislature would be required to provide for the manner in which money from the fund could be used, and could provide for the costs of investment of the fund to be paid from the fund.

For the purposes of constitutional restrictions on the rate of growth of appropriations, the resolution would establish that money in the fund would be dedicated by the constitution and that an appropriation of tax revenues deposited to the fund would be treated as if it were an appropriation of revenues dedicated by the constitution.

On January 1, 2024, the comptroller of public accounts would be required to transfer \$3 billion of the unencumbered balance of the general revenue fund to the Texas Water Fund.

The proposed constitutional amendment would be submitted to the voters at an election to be held November 7, 2023, and the ballot would read: "The constitutional amendment creating the Texas water fund to assist in financing water projects in this state."

NOTES:

According to the Legislative Budget Board, the bill would have an estimated negative impact of about \$3 billion to general revenue related funds during fiscal 2024-2025.

The enabling legislation for SJR 75 is SB 28 by Perry, which is on the Major State Calendar for second reading consideration today.
