Subchapter G, Chapter 503, Occupations Code, is amended by adding Section 503.3025 to read as follows: 5 Sec. 503.3025. EXPERIENCE REQUIRED TO ACT AS SUPERVISOR. 6 The executive council shall allow a license holder who has 7 practiced as a licensed counselor in another state to count that out-of-state experience toward any experience that the license holder is required by executive council rule to obtain to act as a 10 supervisor under this chapter if the executive council determines 11 that the other state has license requirements substantially 12 equivalent to the requirements of this chapter. 13
