1 Amend S.B. No. 700 (house committee report) by adding the
2 following appropriately numbered SECTIONS to the bill and
3 renumbering subsequent SECTIONS of the bill accordingly:

4 SECTION _____. Section 43.621(a), Parks and Wildlife Code,
5 is amended to read as follows:

6 (a) The department shall establish a program for the
7 issuance of permits under this subchapter. In accordance with that
8 program, the department shall [~~may~~] issue a permit for the
9 management of the wild mule deer population to each applicant who
10 satisfies the requirements for a permit.

11 SECTION _____. (a) The Parks and Wildlife Department shall
12 adopt rules to implement Section 43.621(a), Parks and Wildlife
13 Code, as amended by this Act, not later than September 1, 2022.

14 (b) A person is not required to hold a permit for the
15 management of the wild mule deer population as required under
16 Subchapter R-1, Chapter 43, Parks and Wildlife Code, before January
17 1, 2023.

5 Code, is amended by adding Section 11.006 to read as follows:

6 Sec. 11.006. LIMITATION ON ADOPTION OF RULES, REGULATIONS,
7 AND PROCLAMATIONS. (a) Before the commission may adopt a new rule,
8 regulation, or proclamation related to an activity regulated by the
9 department, the commission must repeal two existing rules,
10 regulations, or proclamations related to any activity regulated by
11 the department.

12 (b) The department shall prominently display on the
13 department's Internet website the number of rules, regulations, and
14 proclamations adopted and repealed in accordance with Subsection
15 (a).

7 be killed or processed if the deer was trapped on property on which
8 hunting of white-tailed deer with a firearm is lawful at any time.
