House Committee on Culture, Recreation & Tourism

Charge 1: Monitor the agencies and programs under the Committee's jurisdiction and oversee the implementation of relevant legislation passed by the 86th Legislature. Conduct active oversight of all associated rulemaking and other governmental actions taken to ensure intended legislative outcome of all legislation, including the following:

Charge 2: Study the impact of the Capitol Complex Master Plan and ongoing construction as it relates to the operation and management of the Texas State History Museum, specifically its visitor admissions, educational programming, exhibit space, and facility rental. Examine the connectivity of the Capitol Complex Master Plan Mall area to ensure a consistent, dynamic, and sustainable relationship with the State Preservation Board, Texas State History Museum, and Texas State Capitol in its programming and use. Evaluate the infrastructure needs of the Texas State Capitol and the Capitol Visitors Center to ensure the ongoing preservation and operational needs of the historical structures and grounds.
